



## 2025 Preservation Awards Nomination Prep Document

Each year, Preservation Massachusetts celebrates the individuals and organizations that have made significant contributions to preserving the Commonwealth's historic resources. Preservation Massachusetts will select the 2024 award recipients from nominations received by the **March 31, 2025 deadline**.

The online Nomination Portal does not provide an option to “save” your progress, so we have developed this prep document to assist in organizing your nomination information in advance. We recommend you prepare your answers using this document as a guide and “cut and paste” into the online Nomination Portal.

### **Nominees for the 2025 Awards must meet all of the following requirements:**

- located in the Commonwealth of Massachusetts (for people or organizations, must have a demonstrated history of work in MA);
- completed and currently in service (or completed within the past five [5] years); and
- submitted with a complete application. Incomplete or late nominations may not be considered.

### **AWARD CATEGORIES**

**The Paul & Niki Tsongas Award** (Project/People): Recognizing those that have displayed the highest level of commitment to historic preservation in the Commonwealth.

Criteria:

- Groundbreaking project in terms of scale, difficulty, impact, and significance to preservation in the community, state, northeast region, etc.
- A model of preservation practice, technique, application, and partnership
- Creates and enhances opportunities for the community beyond the rehabilitation of an historic building
- Embodies the ideals, dedication, and belief in community-based preservation exemplified by both Senator and Congresswoman Tsongas

**The Mayor Thomas M. Menino Legacy Award** (Project): Recognizing preservation projects that are transformative, catalytic, embrace the community, create partnerships, and revitalize the best of the past to make something good for the future.

Criteria:

- Accelerates change in the community, in terms of investment and future potential
- Creates partnerships and involves the community
- Embodies the ideals of community, preservation, and belief that Mayor Menino exemplified

**The Frederick Law Olmsted Award (Project):** Recognizing dedication to the promotion of our cultural landscapes.

Criteria:

- Preservation/restoration of an important open space, park, natural resource, landscape, or landscape component of a larger project
- Planning and advocacy efforts on behalf of historic landscape preservation

**The Robert K. Kuehn, Jr. Award (Project):** Recognizing projects that meld collaborative partnerships with creative and cutting-edge ideas for the rehabilitation and active reuse of historic buildings.

Criteria:

- Involves unique and creative partnerships
- Includes green and sustainable elements, practices, or other innovative technologies

**The Charles W. Eliot Award (People/Organization):** Recognizing organizations with exceptional vision and excellence in planning for preservation.

Criteria:

- Advances limits of how preservation is perceived, practiced, and implemented
- Leads in promoting, educating, and expanding the narrative of preservation

**The People's Preservation Choice:** A public vote to select the favorite successful restoration and rehabilitation project. The winner will be announced at the Awards Ceremony on June 6, 2025. Projects nominated for other awards may also be considered for the People's Preservation Choice (PPC). You must opt in to be considered for this award, and you must complete the additional PPC project summary. This is how we will promote your project on our voting site.

Criteria:

- Successful restoration and rehabilitation of a local, state, or nationally significant historic building in Massachusetts
- Project resulted in increased and broadened awareness/appreciation for preservation within the community.

## **2025 PRESERVATION AWARDS NOMINATION QUESTIONS**

### **Nomination Sales-Pitch**

Provide a 1-2 page overview of your nominee and why it deserves a preservation award. Include interesting historic and current facts and major highlights, impacts, and contributions that the nominee has had on preservation in the community. Be enthusiastic and inspiring! Specific details to include:

How does the nominee help positively define preservation?

How does the nominee broaden the understanding, appreciation, and implementation of preservation?

How does the nominee inspire others, both in the preservation field and beyond?

List anything else unique or interesting about the nominee.

Include as many as you wish – we will incorporate this list into our final awards and want to ensure your team knows about the nomination and possible selection as an awardee.

### **Project Nomination Information**

Please include a 1-2 page, detailed project narrative that includes information such as both the historic and current usage, completion date, project development costs, funding sources, challenges overcome, improvements and benefits to the community, historic preservation elements, economics impact, use of technology, sustainability goals, etc.
